Chittaranjan National Cancer Institute Kolkata an autonomous body under the Ministry of Health & FW, Govt. of India consisting of a research center and a 200 bed hospital invites application for the post of **Director** from **Essential qualifications :- A.** MD/DNB Radiotherapy, Or (ii) DM/DNB Medical Oncology, or (iii) MCH/DNB Surgical Oncology from a recognized University or equivalent. **B.** 15 years teaching / research / clinical experience in the relevant field with a minimum of 5 years administrative experience in a supervisory capacity. **Desirable :** Degree / Diploma in Hospital administration from a recognized university / Institution in a supervisory capacity on direct recruitment/transfer on deputation in the pay band of **Rs.37,400-67000 (PB 4) and Grade Pay 10,000 plus NPA for medically qualified person.** **Age limit (for direct recruitment):** Not exceeding **50** years relaxable for government servants up to 5 years. The Chittaranjan National Cancer Institute consists of a Research Centre carrying out modern research on various aspects of Oncology, a 200 bed hospital imparting advanced treatment to cancer patients, and a Preventive Oncology Centre. The Institute has recognition as a Science and Technology Institute by the Government of India, Department of Science and Technology and is functioning as an autonomous Institute under the Ministry of Health and Family Welfare, Government India. The GOI has also approved the 2nd Campus of CNCI as a State of the Art Cancer Management Institute for cancer diagnosis, comprehensive treatment and cancer research, in first phase with 460 bedded hospital.

CNCI invites applications in the prescribed format (Annexure-1) for the following post to be filled up on Direct Recruitment / Transfer on Deputation (including short term contract) :

- (i) Name of the post : Director
- (ii) Pay Band and grade Pay : Band Pay of Rs. 37,400-67,000 (PB-4) plus Grade Pay of Rs. 10,000/- plus NPA for medically qualified person
- (iii) Method of Recruitment : Direct Recruitment/Transfer on deputation (including short term contract) Transfer.
- (iv) Tenure : The Director so appointed shall hold office for a term of 5 years from the date on which he assumes charge of the post or until he attains the age of 60 years, whichever is earlier.
- (v) Age limit for direct recruitment : Not exceeding 50 years, relaxable for government Servants upto 5 years in accordance with the instructions or orders issued by the Central Government.

Note : The crucial date for determining the age-limit shall be the closing date for receipt of applications from candidates in India (and not the closing the date prescribed for those in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh division of J&K State, Lahaul & Spiti district and Pangi Sub Divisions of Chamba district of Himachal Pradesh, Andaman and Nicobar Island or Lakshadweep).

(vi) Educational and other qualification required

Essential :

A. (i) MD/DNB Radiotherapy,

Or

(ii) DM/DNB Medical Oncology, or

(iii) MCH/DNB Surgical Oncology from a recognized University or equivalent.

Desirable

B. 15 years teaching / research / clinical experience in the relevant field with a minimum of 5 years administrative experience in a supervisory capacity.

Degree / Diploma in Hospital administration from a recognized university / Institution.

Period of Probation

Two years for direct recruitee.

In case of recruitment by promotion / deputation / transfer, grade from which promotion / deputation / transfer to be made.

For transfer on deputation (including short term contract / transfer, officers in the Central / State Govt. / Autonomous Organizations / Research Institutes / Universities, etc. and –

- I. (a) holding analogous posts on regular basis; or
- (b) with 2 years regular service in PB-4 (Rs. 37,400-67,000) with Grade Pay of Rs. 8900 or equivalent or
- (c) with 3 years regular service in the PB – 4 (Rs. 37,400-67,000) with Grade Pay of Rs.8700 or equivalent and
- II. Possessing education qualification and experience prescribed for direct recruitment.

Other conditions:

1. Period of deputation (including short-term contract) including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed five years. The maximum age limit for appointment by deputation shall be 56 years on the closing date of the receipt of applications.
2. For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended) shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale and where this benefit will extend only for the post (s) for which that grade pay or pay scale is the normal replacement grade without any up gradation.
3. Disqualification—No person:-
 - (a) Who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

4. Power to relax: where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules except condition 3 above with respect to any class or category of persons.
5. Saving:- Nothing in these rules shall effect reservation, relaxation of age limit and other concessions required to be provided for the scheduled Castes, the Scheduled Tribes, Other Backward Classes, the Ex- Serviceman and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
6. Pre-appointment formalities like verification of character antecedents required before appointing a person for the post from open market.
7. The other instructions issued by the DoPT/ACC from time to time on the above subject may also be followed.

The following documents also need to be sent with the application:

- (i) Vigilance Clearance
 - (ii) Integrity Certificate
 - (iii) Major/Minor penalty of statement during the last 10 years.
 - (iv) Cadre Clearance from the cadre controlling/ appointing authority, if applicable: and
 - (v) Photocopies of ACRs/APARs of last five year duty attested by an officer not below the rank of Under Secretary of the Govt. of India. If for some reasons, the ACRs/APARs of the officers have not been written for a particular year or a part (for more than three months) of a year, a “ No Report Certificate” (NRC) for that period may be sent along.
