TERMS & CONDITIONS OF TENDER ENQUIRY

1. Tenders must be submitted on this Form, otherwise they are liable to be ignored. In case of detailed particulars additional papers may be enclosed to it.
2. Preference will be given for offers with specific deliveries and firm prices F. O. R. destination asked.
3. Prices should be net F. O. R. destination inclusive of rise in transit and remain valid for minimum thirty (30) days from the date. They should be written both in figures and words.
4. Quotation should, as far as possible, be free from corrections and erasures. Corrections, if any, should be initiated complete details, such as maker's name and place should be given and illustrated literature included wherever possible.
5. No revision in prices will be entertained after the tenders are opened.
6. Quotation should indicate whether VAT is included or is payable as an extra to the quoted price. If the latter, the relevant registration certificate number and date should be mentioned.
7. Quotations will be ordinarily opened on the working day following the Due date. But it may be deferred also by few days.
8. Wherever necessary/ asked, samples should be submitted separately from the quotations, so as to reach us on or before the Due date of the enquiry, they should be clearly marked with the identification. Quotations without samples are liable to be ignored.
9. Materials must be despatched within the time and subject to the conditions specified in the order, otherwise CNCI will be at liberty to cancel the order and/ or Purchase the materials in the open market at the risk and the cost of the suppliers and recover from the suppliers any loss or damage occasioned thereby. CNCI may give reasonable notice at its discretion on such terms and conditions as it thinks fit but without prejudice to any other rights of the CNCI.
10. INSPECTION & PAYMENT TERMS : Unless otherwise specified, Inspection will be at the Firm's premises/ Factory/ Godown or at the destination. 95% payment will be made on proof of despatch and inspection within 7 days from the date on receipt of the bill and the balance 5% on receipt of the consignee's receipt.
11. Goods despatched either by V. P. P. or by documents presented through Banks will not be accepted unless previously so arranged with the CNCI.
12. DISPUTES : In all cases of disputes the decision of the CNCI shall be final, definitive and binding on the supplier.
